

**The FJC model brings victim services under one roof. This lessens the trauma for those who have already been victimized. They only have to tell their story one time.**

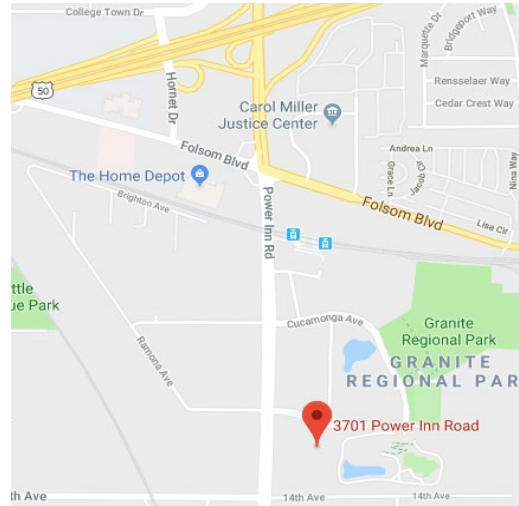
The core concept is to provide one safe place where victims of domestic violence, elder abuse, and those who have been trafficked can talk to an advocate, plan for their safety, apply for a Temporary Restraining Order, meet with law enforcement, receive trauma informed counseling, social services, spiritual care, and more.

The FJC is highly collaborative – we do not duplicate the excellent work and services of our community partners. We simply help to coordinate, comfort, and bring hope to those who have suffered abuse.

The U.S. Dept. of Justice has identified the Family Justice Center model as a best practice in the field of domestic violence intervention and prevention services.

## Frequently Asked Questions

### Who can get help at FJC?

FJC helps survivors of domestic violence, elder abuse, child abuse, sexual assault, and human trafficking.

### Do I need an appointment?

No. Everyone who comes to FJC is seen on a first-come, first-serve basis.

Depending on individual need for services after an initial visit, follow-up appointments may be scheduled (e.g. for legal support, medical care etc.)

### What should I bring?

If you have them, we recommend bringing legal documents such as existing restraining orders, child custody and visitation orders, and police reports.

### Can I bring my children?

Yes, we have a play area designated for children. As childcare is not always available, we recommend bringing another adult to watch young children while you receive services.

### Do I need to bring an interpreter?

Many of FJC's staff members are bilingual. We will do our best to arrange an interpreter to assist you if needed.

### Can I volunteer or do an Internship at the FJC?

Yes. All interns are screened and will go through training.

## Community Partners
